In Appreciation of Matt Chase



With great admiration and appreciation, we said farewell to Matt Chase on September 14, 2012. After 15 years with NADO, Matt moved to the National Association of Counties (NACo) to become their new executive director.

Joining NADO as legislative director in 1997, Matt rose through the ranks quickly: In 2000, he became deputy executive director and within another three years he was selected to become NADO's second executive director. Under his leadership, NADO grew to become a prominent advocate for the nation's regional development organizations and for the critical role they play in providing regional approaches and solutions to local challenges.

Matt's acumen for policy issues and the impact of federal legislation on the programs and services that regional development organizations nationwide offer helped NADO achieve a number of legislative victories during his tenure. He played a significant role in the 1998 five-year reauthorization of EDA, and the first increase in planning support to EDDs in over 20 years. Understanding the importance of the Economic Development Administration's planning support to NADO members, he has fought tirelessly over the years to retain EDA in the federal budget by sharing the successes, lessons learned and noteworthy practices of economic development districts across the nation.

His foresight led to many of NADO's partnerships with the American Association for State Highway and Transportation Officials, NACo, and the Federal Highway Administration to develop rural transportation planning organizations similar to metropolitan planning organizations. This coordinated effort led to rural transportation language in federal regulation in 2003 and in the surface transportation law passed in the summer of 2012, Moving Ahead for Progress in the 21st Century (MAP-21).

His work on the Farm Bill was instrumental in developing innovative regional cooperative development initiatives that sought to implement the innovative regional development strategies of RDOs. And he collaborated with other entities to prompt the Department of Homeland Security to develop policies requiring the development of regional homeland security planning processes.

His vision for NADO's role in the larger landscape of community and economic development allowed NADO to become a leader in rural brownfields training, to spark new alliances with agencies and organizations engaged in sustainable development initiatives, to develop relationships with new philanthropic partners, and to create strategic alliances with other national and regional groups that support rural development.

We wish Matt the very best as he embarks on his new journey with the National Association of Counties.

Kentucky County Officials Training Credit

Kentucky's training incentive program for elected county officials began with the enactment of House Bill 810 (KRS 64.5275), effective in January 1999. The program offers county judge-executives, fiscal court members, clerks, sheriffs and jailers an annual financial incentive to participate in continuing training relevant to their official duties. NADO's 2012 Annual Training Conference is an approved




