The Regional **Export** Network (REN) serves as a liaison in between PA companies and 21 PA trade offices strategically located throughout the world.

#### Pennsylvania International Week (PIW)

Pennsylvania's ATR's meet with companies seeking foreign market intelligence, agents and distributor candidates, industry and government contacts, as well as on-the-ground assistance when visiting these markets.

One on one meetings with companies interested in exporting to the countries the ATR represents

Work Order defines the procedure, flow, and parties involved in the issue. It provides tool for on-line tracking and completion of requests.

The work order is a formal request by a PA company, deemed export ready by REN, for a specific service offered by Authorized Trade Representative in one of the 21 the Foreign Trade Office.

CTD contracted with Team Worldwide, TÜV Rheinland, and Cohen and Crigsby to offer export counseling and compliance advice.

- Team Worldwide will offer counseling of export controls, letter of credits, Free Trade Agreements, and more.
- TÜV Rheinland will offer expertise in product certification requirements for foreign market access such as CE mark, WEEE, RoHS, REACH, EMC, CCC mark, etc.
- Cohen and Crigsby will offer legal council on international trade related questions.
