# 2020 AT A GLANCE

The year 2020 marked the first full year in implementing NADO's Strategic Action Plan, which was approved by the NADO Board of Directors in August 2019. The Plan's six pillars—Build Institutional Change, Create New Partnerships, Promote Organizational and Staff Capacity, Broaden Advocacy and Networking, Expand Operational Resources, and Strengthen Membership Base—provide a roadmap

for our path forward. Much has been accomplished in this first year of the five-year plan. A full report can be found on **www.NADO.org**.

After over 30 years, **an office relocation** took us from the Hall of the States building to larger and more accommodating space in early 2020. The new space is better suited for our expanding staff and more favorable to our bottom line. We enjoyed our space for about six weeks before the COVID-19 global pandemic moved us all to working from home. We worked from home through the end of 2020 but look forward to being back in our offices sometime in 2021.

Although the **COVID-19 pandemic's impact** on our nation's economy presented numerous obstacles, the pandemic has also illustrated that NADO members can meet adverse challenges and situations head-on and continue to meet the needs of the communities they serve. Between March and September, NADO surveyed members three times to learn more about the ways they were responding to the pandemic, how it was impacting their daily operations, and to understand how they were using Coronavirus Aid, Relief, and Economic Security (CARES) Act funds designated specifically for U.S. Economic Development Administration (EDA)-funded Economic Development Districts (EDDs). NADO members shared their strategies for continuity of services, the immediate challenges posed by the pandemic, and outlined ways that federal programs could help them continue to provide services to residents. This information was beneficial for NADO staff as they worked with staff on Capitol Hill and in various federal agencies to better understand NADO members' immediate and long-term needs. Input from the membership was vital to NADO's advocacy work which resulted in increased funds for the EDA and EDDs in the CARES Act.

### 2020 AT A GLANCE

**NADO's major membership events**—the NADO-DDAA Washington Policy Conference, the National Regional Transportation Conference, and the Annual Training Conference—put NADO staff into full learning mode as new training platforms were researched, tested, and ultimately used to conduct the events virtually. While we all missed the energy and synergy of meeting in person, we were thrilled that so many members and others from various federal agencies and national organizations attended these events and benefited from virtual training and networking opportunities.

As part of our initiative to expand organizational resources, the **Research Foundation secured more than \$1.5 million in new grants and contracts** in 2020. These multi-year grants will allow the Research Foundation to continue its research, training, and information-sharing work in regional resilience, organizational capacity building, and rural/regional transportation. During the 2019 NADO Annual Business Meeting, the association approved the first modification to its dues structure in almost 20 years. The **increased membership dues will further NADO's advocacy efforts on behalf of our members**; it will also help us build our strategic partnerships with other national organizations.

During the past year, NADO and the NADO Research Foundation hired **new staff as part of a strategy to enhance organizational capacity**. We are pleased to have added a Membership and Meetings Manager, a Database and Grants Manager, and Graduate Fellows to our team. The **Association's**

### ADVOCACY HIGHLIGHTS: NADO SUCCESSFULLY ADVOCATED FOR EDA FUNDING REFORMS

In collaboration with other national partners, NADO's legislative team successfully advocated for the inclusion of **\$1.5 billion in supplemental funding for the U.S. Department of Commerce Economic Development Administration (EDA)** within the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), which was signed into law on March 27, 2020.

NADO also successfully advocated to reform the EDA Revolving Loan Fund program in order to increase the program's efficiency and extend more local flexibility to EDA RLF operators. On October 30, 2020 the Reinvigorating Lending for the Future Act of 2020 (RLF Act) was signed into law.

### **LEGISLATIVE** & ADVOCACY HIGHLIGHTS

Working with a coalition of national partners, NADO's legislative team successfully advocated for the inclusion of \$1.5 billion in supplemental funding for EDA within the CARES Act, which was signed into law on March 27, 2020. A significant portion of the additional funding appropriated to EDA via the CARES Act was in turn allocated to Economic Development Districts (EDDs) and EDA Revolving Loan Fund (RLF) operators to support their efforts to facilitate economic recovery and mitigate the impacts of the COVID-19 pandemic on their regions. The CARES Act also provided supplemental funding for other programs and agencies that are important to NADO members, including the U.S. Department of Agriculture, the U.S. Department of Health and Human Services, the U.S. Department of Housing and Urban Development, the U.S. Department of Labor, the U.S. Small Business Administration, and the U.S. Department of Transportation, among others. In collaboration with other national stakeholders, NADO advocated for supplemental funding for these agencies in advance of the passage of the CARES Act and will continue to advocate for these agencies' funding and programs in the future.

Following the passage of the CARES Act, EDA provided non-competitive funding directly to EDDs and EDA RLF operators in good standing to help support their regional efforts to mitigate the economic impacts of the COVID-19 pandemic. EDA also released new guidance on increased flexibilities for EDA RLF operators in recognition of the pandemic's impact on small businesses and the increasing demand for RLF loans. The provision of this supplemental funding—in combination with EDA's innovative efforts to infuse funding into communities rapidly—supported NADO members' early efforts to help their communities begin to combat the many challenges posed by the pandemic.

### LEGISLATIVE & ADVOCACY HIGHLIGHTS

NADO also successfully advocated to reform the EDA Revolving Loan Fund program in order to increase local flexibility and reduce administrative burdens for EDA RLF operators. NADO worked closely with Senator Capito (R-WV), Senator Cardin (D-MD), Congressman Peterson (D-MN), and Congressman Katko (R-NY) who jointly introduced two bipartisan, bicameral bills (S. 4075 and H.R. 7388) entitled the Reinvigorating Lending for the Future Act (RLF Act) of 2020. After passing in the House and Senate, the RLF Act was signed into law on October 30, 2020, and became Public Law 116-192. The RLF Act reforms the EDA Revolving Loan Fund (RLF) program by eliminating burdensome "in perpetuity" reporting requirements and releasing the federal interest in EDA RLFs after seven years, thereby providing increased local flexibility to EDA RLF operators as they administer the program on behalf of their communities. The legislation permits EDA to release the federal interest in RLFs that have operated satisfactorily for seven years since the disbursement of grant funds. The passage of this legislation will improve the efficiency of the EDA RLF program during a time when the program is of paramount importance, as it is helping small businesses combat the economic consequences of the pandemic.

In addition to NADO's advocacy efforts surrounding EDA programs and funding, NADO continues to advocate for robust funding for other federal agencies and programs that support economic and community development work, many of which received supplemental federal funding via the CARES Act. NADO will continue to work with other national stakeholder organizations and coalitions that collectively identify and advocate for shared priorities. Following the November 2020 general election, NADO's legislative team began working with members of the incoming administration's transition team to relay guidance and input for the next administration's consideration.

NADO is grateful to the many NADO members, coalition partners, and other advocates who engaged members of Congress and helped advocate for NADO's legislative priorities this year, as well as the Senate and House champions who introduced legislation and the congressional staffers who dedicated their time and support. NADO extends our appreciation to the Ridge Policy Group for their work in support of NADO's advocacy goals, and we thank the NADO membership for approving a dues increase in 2019 which allowed NADO to direct additional resources toward advocacy in 2020.

## RESEARCH FOUNDATION HIGHLIGHTS

## RURAL AND REGIONAL TRANSPORTATION

The Research Foundation's focus on rural and regional transportation was enhanced in 2020 with **support from the U.S. Department of Agriculture (USDA) to provide technical assistance to rural and tribal transit programs** in 11 states and two Native American reservations. We **completed a multiyear project on Intelligent Transportation Systems (ITS) with funding from the Federal Highway Administration**. Our project work has resulted in 14 case studies and reports covering topics such as transportation technology and operations, travel information and transportation, transportation and safety, and rural ITS (available on www.RuralTransportation.org).

In 2021, our work in the rural transportation world will expand with **new funding from the National Academies of Sciences** to research the connections between transportation and job access in rural communities, and Cambridge Systematics to provide technical support on projects related to rural highway safety. In addition, a new grant from USDA will allow us to continue delivering technical assistance to rural transit programs.

**RPO America** continues to provide a valuable service to NADO members who are engaged in rural transportation planning. Through **www. RuralTransportation.org** we are able to provide relevant and timely resources. And, while we were not able to meet in person for the 2020 National Regional Transportation Conference, we are hoping we can hold the conference in 2021 in Kansas City, MO, July 20 – 22.

#### RESILIENT REGIONS & COMMUNITIES

With support from EDA, we continue to manage and deliver the Stronger CEDS, Stronger Regions program to assist EDDs and other regional organizations with their CEDS planning, writing, and implementation efforts. In 2020, we expanded the breadth of resources available at www. CEDSCentral.com, delivered the Summertime with the CEDS webinar series that covered nine topics related to the CEDS and economic resilience and recovery, published 10 CEDS in Action case studies, hosted a series of Data Deep Dive webinars, and provided a mix of desktop consulting and technical assistance to EDDs working on their CEDS. EDA's generous support will enable us to continue this important work through 2021.

Our partnerships with the University of North Carolina (UNC) and the Center for Creative Land Recycling (CCLR) have resulted in connecting NADO members with information and resources about small water systems management (UNC) and training about brownfields as an economic development strategy (CCLR). Our collaboration with the Rural Community Assistance Program (RCAP) focusing on rural wealth creation continues.

#### A new partnership with Smart Growth America (SGA), the Nuclear Decommissioning Collaborative, and CCLR, funded by EDA,

includes an 18-month project to work with nuclear power plant host communities to better prepare and respond to the significant economic challenges posed by plant closure.

#### ORGANIZATIONAL CAPACITY BUILDING

In early 2020, the EDA Austin Regional Office committed to another round of multi-year funding to further our partnership with the Southwest Region Economic Development Association (SWREDA) to provide event planning assistance and support our work on the Training Program for Emerging Leaders. The EDA Denver Regional Office is providing support for the Research Foundation to work with the Iowa Association of Councils of Governments to develop a conference for four states in the region.

A new opportunity with EDA Headquarters in 2021 will enable the Research Foundation to develop an EDD curriculum and an EDD peer mentoring program.

#### RESEARCH, INFORMATION, AND TRAINING

The primary goals of the Research Foundation are to conduct research, disseminate information, and deliver training that is responsive to our membership. These goals are achieved largely through myriad grants and contracts secured through a robust fundraising effort. The Research Foundation team also manages the NADO Member Inquiry platform; over the past year information shared among the membership covered position descriptions, examples of RFPs, tiny home ordinances, community rating systems, rural housing programs, social media policies, rural community livability, mapping systems, and other topics related to EDD organizational structure and program development and delivery.

In 2020, the Research Foundation launched the RDO COVID-19 Resource Center and the Equity and Inclusion Resources for RDOs page on www.NADO.org. Updated regularly, these pages offer a variety of resources to the membership including member examples, training events, federal and private philanthropic resources, information from other national organizations, tools, and other resources.

#### RESEARCH, INFORMATION, AND TRAINING

The Research Foundation team **develops the content for NADO's Annual Training Conference (ATC)**. While pleased with the outcome of the 2020 Virtual ATC, we are hopeful the 2021 ATC will occur as planned in Portland, OR, October 16 – 19.

The NADO Research Foundation receives invaluable input from the NADO Research Foundation Advisory Committee and the National RPO Council of Peers. The Advisory Committee—eight members representing each of the NADO membership regions, the Associate membership category, and the Research Foundation Board of Directors—provides ideas for further research and training. Committee members are selected by the NADO Research Foundation Board of Directors. The RPO Council of Peers serves as the leadership of RPO America and provides advice, input, and ideas to NADO. Members are appointed by the NADO President, with the advice and consent of the NADO Board of Directors.

In addition, collaborating with partners on key topic areas through events, conferences, and training enables NADO to build new connections, as well as create and share timely information.
