When you look at the types of expenses covered in a federal grant budget, you might conclude that there are really three main categories—people, places for them to work, and assets they need to use. Travel, equipment, supplies, services, and even rent—should be acquired using procurement methods that reflect federal government standards contained the Office of Management and Budget's "Uniform Guidance." In between the implied advice to "shop around" and "get what you pay for" the standards impose requirements for soliciting offers, evaluating bids or proposals, and placing contracts with the correct clauses. This session will provide a practical overview of how to manage those administrative duties that are critical to the success of your federally funded projects.

Most federal grants include an Indirect Cost line item which allows grantees to include expenses that are not directly tied to a specific grant but are needed for the organization to operate such as rent and utilities. Grantees negotiate Indirect Cost Rates with a federal agency—typically one that provides the greatest amount of financial support. This session will encourage you to take a fresh look at the current federal policies for indirect cost recovery and determine how best to justify and support the approaches that you will use going forward in future negotiations with your cognizant agency.
