

### Who is ECWRPC

East Central Wisconsin Regional Planning Commission (ECWRPC)

- Created in 1972 under Wisconsin State Statute (§66.945, now §66.0309)
- Established to promote intergovernmental cooperation, regional planning, and a shared vision for the future
- Serves as a coordinating organization among federal, state, and local governments in the region
- Provides technical assistance, data, and planning services directly to individual units of government
- Supports communities in transportation planning, economic development, environmental stewardship, and community design
- Designated as the region's Economic Development District (EDD) by the U.S. Economic Development Administration (EDA)
- Recognized by the U.S. Department of Transportation as the Metropolitan Planning Organization (MPO) for:
  - Appleton (Fox Cities) MPO
  - Oshkosh MPO
  - Fond du Lac MPO (designated in 2002)





### WHAT is SPARC?

- Assists Wisconsin communities under 12,000 population
- Aims to energize and inspire new ideas for development, capacity building, and downtown/commercial corridor revitalization
- Provides free design and technical assistance to help communities visualize projects and explore new possibilities
- Helps develop realistic, prioritybased projects that align with each community's long-term goals
- Brings together a team of subjectmatter experts in:
  - Economic development
  - Transportation and planning
  - Engineering
  - Landscape architecture

Entirely free of charge to participating communities





### Wrap Around Services

- Continue to work assist communities after the SPARC program to complete projects
- Dedicated Grants Coordinator added to the team
- Wrap around service with an emphasis on:
  - Matchmaking and grant identification
  - Application guidance
  - Ability to bring these projects to fruition





## Application and Selection Criteria

- Competitive application process; communities were required to submit an application identifying focus area and stakeholders
- Received 26 applications in 2021, selected 8 communities
- Received 15 applications in 2022, selected 4 communities
- Received 9 applications in 2023, selected 4 communities
- Received 6 applications in 2025, selected 6 communities








### **The New London Loop**

### City of Omro – Downtown Plan


### **Key Recommendations**

- Along Webster Avenue, pursue development on each side, with closures for events
- Remove parking at the base of the pedestrian bridge to create a seamless connection south
- Demolish the former Dollar General building and redevelop as retail
- Pursue townhome development on W Huron Street
- Continue conversations with DOT on stop signals along Highway 21
- Pursue new Public Works/EMS outside of downtown, market current Public Works site for redevelopment




